307/16	 To RECEIVE INFORMATION FROM FIRST RESPONDER GRAHAM MELVILLE REGARDING THE FIRST RESPONDER SCHEME AND THE PURCHASE OF A DEFIBRILLATOR FOR THE VILLAGE Graham provided a summary of his experience as a first responder for Chale and the surrounding area both in relation to the use of defibrillators and what is involved and expected as a first responder volunteer. He provided contact details for Louise Walker, Head of Ambulance Training and Community Response Services regarding CPR training opportunities should the application be successful. The Wight Mouse have been fundraising for a defibrillator for the village for some time and will continue to do so until the outcome of the application is known and have secured the help of a local electrician with regards to installation. To ratify the funding application made to the British Heart Foundation for two defibrillators for the village, one to be located outside the Wight Mouse, the other outside Chale Stores RESOLVED That the application to the British Heart Foundation is ratified To agree next steps for installation and maintenance of the equipment, and training (offering CPR training in the community being a pre-requisite to the application) RESOLVED Next steps will be discussed and agreed in conjunction with the ambulance service should the BHF application be successful. 		
308/16	DOCTORS SURGERIES To discuss the proposed restructuring and possible closure of rural GP surgeries		

Cllr Paragreen reported back from a patient's participation group he attended at Niton Surgery where the threat to GP surgeries was discussed at length. Dr. Peter Hill of South Wight Medical Practice had seemed confident that Niton and Brighstone would remain but that Godshill, being the least used practice due to its better transport links with other towns, was most under threat. This proposal has been driven by central government and the belief that patients prefer to be treated in large practices, such as the two largest practices on the island, Cowes and Sandown, but these are both apparently struggling to keep doctors. Cllr Paragreen has calculated that if only Brighstone remains, it would take Chale residents 5 hours to get to Brighstone and back to attend an appointment on the bus and that's if everything went smoothly. Members of the public were invited to share their thoughts on the issue and were vocal in their concerns for the elderly population in particular and difficulties with transport, strongly opposing any proposed closures

311/16 TO REVIEW THE PRESENTED BUDGET FOR 2017/18 AND SET THE PRECEPT

The presented budget was reviewed and the spending of reserves compared to last year to support community grants such as St Andrews Churchyard, SWAY, and the number 6 Sunday bus service noted.

RESOLVED

To cover expenditure for next year and to continue to support the village with the bus service and other grants, and protect reserves for ring fenced projects, an increase of $\pounds1000$ is necessary and the precept for 2017/2018 is set at $\pounds10000$.

If the grant element of the precept from the IWC remains the same this will mean an increase of £4.16 a year for a band D property, paying a total of £37.44 per year.

No further information has been received regarding access to the necessary wayleaves from the two landowners. The Chairman has written to Wendy Perera at the IWC to see how the PC might be able to work with them to assist the 51 households left without access to the programme, and is awaiting a response.
