14/18 CHALE COMMUNITY HUT

1 To consider and agree to taking on the legal ownership and responsibility for the community hut

To agree on the receipt of Southern Housing Group's grant of £5000; £3500 of which to be used for long term running costs and £1500 to be ring fenced for future disposal RESOLVED

That the parish council agree to taking on ownership and responsibility for the hut, and receive associated funds of £3500 for maintenance and £1500 ring fenced for disposal, however only after it is in a good state of repair. The Chairman to communicate this to Mark Meredith of the Southern Housing Group. Mark Meredith of the Southern Housing Group confirmed to the Chairman after the meeting that they would instruct the contractors to start work as soon as possible and will be in touch with the licence agreement and grant agreement once this has been done.

In lieu of the hut being useable SWAY have been renting a Youth Bus through Community Action IW which has been very successful but this is costing money and there are only 3 paid weeks of rental left. Councillors representing the community hut working group asked IW Councillor Stewart if he could confirm who owns the youth bus and whether it is possible to have it, given that they understand it hasn't been used at all in the last 6 months? Alternatively, whether there is a spare old council owned mobile classroom that could replace the hut? Modular buildings were also briefly discussed as a solution and have been priced up initially at £20,000 but could these be sourced more cheaply? Agreed this could be a longer-term solution but will not resolve the current lack of facility for SWAY.

IW Councillor Stewart to confirm possibilities with the youth bus and whether there are any mobile classrooms available.

Member of the public present at the meeting confirmed his offer of toilets, sinks etc left over from refurbishing his business is still there, but he may only be able to continue to store these up until Easter

15/18 PHONE BOX ON THE MILITARY ROAD

To discuss and agree a plan for the phone box's refurbishment

Due to its prominent position and high winds it is becoming dangerous – the chairman has twice now attempted to tie it up with rope to stop it flapping open, but this solution isn't sustainable. Since being informed by the IWC that a listed building consent application to remove the phone box wouldn't be supported, the Chairman has spoken to Dave Badman who would be happy to refurbish the phone box and Councillors asked whether there would be any financial support available from the IWC/grants/charities to help pay for its repair.

16/18 HOY MONUMENT

To receive a response from the National Trust regarding the proposed donation

The chairman and the clerk met with Tony Tutton from the National Trust on Wednesday 31st January at their office in Mottistone. The National Trust are interested in taking on the Hoy as it is on their land but they need to look at getting it endowed before they can agree to anything. They have asked for a survey and estimate of projected costs over a 10-year period in order to calculate the endowment. Subject to councillor's approval the clerk has arranged for Wight Stonemasonry to look at it on Wednesday 21st February. There will be a small cost for this survey.

17/18 TO RECEIVE REPORTS FROM:

- 1 The Clerk with any correspondence received
 - Meeting attended by the chairman and clerk at the IWC re. IWC budget for Chale impacted areas are the youth service and park's maintenance. We were asked whether there any services currently provided by the IWC that the we could take on but we fedback that as we are a small rural parish we would not be in a position to undertake additional services in the same way that some of the larger town and parish councils can
 - Regarding Park's maintenance we have received a letter from the recreation and
 public spaces manager at the IWC confirming no increase this year for our grass
 cutting contract on the green, honouring the third year of our three-year agreement.
 They are however looking to retender its grounds contract and will provide us with
 costs in the autumn in time for our budget and precept setting for next year
 - Letter from the chairman was written last month in support of the Church council's funding application to refurbish the vestry and install toilets
 - Confirmation that the 2018/9 council tax base for Chale is 251.7 and the IWC council tax support grant will be £423. This will mean a total precept of £9577 and the band D council tax will be £38.05 for the year
 - Details of the Isle of Wight Foundation funding have been received and forwarded to the hut management group, SWAY and Chale Together
 - Thank you letter received from SWAY for the £500 awarded by the PC last month
 - Contacted by a company called Selectra who are working in conjunction with the smart meter authorities to publicise the UK Government's roll out of Smart Meters to all homes and business by 2020. They have forwarded the government links and have asked that we put these on our website? It was suggested that this was a price comparison company and therefore councillors didn't feel appropriate to advertise
 - Email from IW Councillor Michael Murwill keen for as many people to participate in the Great British spring clean campaign between the 2nd and 4th March 2018, details forwarded via email prior to the meeting. Cllr Bernasconi to put on Facebook and a litter pick for the green to be organised for May and to go on April's agenda
