95/18 AGE FRIENDLY ISLAND CHARTER

To receive Chale Parish Council's Age Friendly Charter from Lisa Toyne, Age Friendly Communities Development Officer

Lisa Toyne, Age Friendly Communities Development Officer provided an overview of the Age Friendly Charter funded by the national lottery and managed by Age UK before presenting the Charter to the Chairman. Amongst various initiatives such as Men in Sheds and the Aging Better Programme, they carry out age friendly training for organisations including the police and fire service, and having successfully trained Southern Vectis staff, training has now been extended to the whole of the Go-Ahead Group on the mainland. Funding exists for another year at which point Age UK are looking to find sustainable funding in order to continue. Questions were raised about the future of the Local Area Co-ordinator's role and how they link with local churches.

98/18 ISLAND ROADS VOLUNTEERING SCHEME AND COMMUNITY PAYBACK

To consider any projects that could benefit from the support of either Island Roads' Volunteers or Community Pay Back

Community Pay Back are due to cut back the vegetation around the hut on the 17th November and it was agreed to keep both these organisations in mind as and when projects come up in the future. A member of the public present at the meeting suggested the bus shelter opposite the post office could do with cleaning and painting.

No further progress reported. Cllrs have noticed that the hut is rotting where the shed used to be.

100/18 CHALE STORES

To receive an update and agree on any next steps

The Chairman reported there has been no response from the owner of the freehold to his email asking about a potential sale and sale price after nearly a month. The Chairman will send an email reminder after a month to ensure he has received this email. Cllrs confirmed the lease is still up for sale at a reduced price but that the leaseholders are committed to giving the Spar at least 3 months.

The Clerk has circulated information and figures about a government loan to councillors, and contacted the National Lottery and identified the London and South East's Reaching Communities funding stream to apply for should we be in a position to purchase the freehold. Providing it is a not for profit venture and will benefit the community we would be eligible to apply.

101/18 CHRISTMAS TREE

To receive confirmation from Chale Together regarding this year's arrangements

Cllrs representing Chale Together asked about the possibility of buying a pre-decorated tree. The Clerk will forward information gained last year from a company used by some town and parish councils known to pick up, decorate and remove Christmas Trees. Solar lights purchased last year thought to be risky given the little sun light likely at the time of year and so new lights will need to be purchased. It was not known who to approach regarding Hawthorn Cottage which would be the ideal location for a power source. If this isn't an option they will run an extension cable from the shop. Cllrs confirmed the café will be open for mulled wine and mince pies for Carols on the Green, Thursday before Christmas.

103/18 TO RECEIVE REPORTS FROM:

- 1. The Clerk with any correspondence received
 - IWC Grass cutting contract has been extended for another year at a cost of £500 plus VAT
 - National Trust have asked whether we have any specific access rights to the Hoy
 Monument other than the public rights of way. The Clerk contacted Wight
 Stonemasonry who worked on the Hoy many years ago who had access via
 Crocker Lane at Kingates to the top of Head Down and then drove over the Downs.
 - Broadband IWC have confirmed this will be a two-stage process. Some trenching
 work will take place prior to half term and the remainder of the work will be
 completed in November.

• The Clerk contacted Shorwell PC re. building works at Corve farm. They were not aware of any planning application and had been informed they were restoring the buildings. Prior to the meeting the owner of Corve Farm shared with the Chairman and clerk his plans which include a facility to help young people and the creation of a vegan cheese factory. The chairman advised that as the property is within the parish of Shorwell, that it would be for Shorwell PC to comment on the plans. The Clerk will forward contact details and confirmation of meetings to the owner.

3. Parish Councillors

- Cllr Paragreen continues to attend the South Wight Parishes Health Forum. Cllr O'Harrow will attend the next meeting in Ventnor
- Cllr Paragreen reported that Chale Together will be submitting a grant request to the PC to support the Chale Mail. Next meeting date 18th October
- Cllr Bernasconi reported there will be a photography walk on 21st October organised by Chale together following a very successful 'bat walk' recently
- The Chairman reported he has been approached by SWAY about a grant as a percentage of the precept in comparison to other parishes
- The Chairman reported he and two local residents have put in 20 hours so far
 working on the phone box. It was questioned what we are going to do with it when
 its finished and one suggestion has been offered to create a timeline of the village
 which goes back to 1040 and naming it the 'smallest museum on the Isle of Wight'
- The Chairman raised the need for a meeting with Alex Dabell re. the overgrown trees blocking the view at Blackgang and IW Cllr Stewart agreed to join the chairman to try to progress this matter
- The Chairman reported that on 19th October he will be doing a draw for the garage in aid of breast cancer
- The Chairman shared news via a local resident present at the meeting that Chale was runner up in the medium category of the Isle of Wight Best Kept Village Awards 2018

The Chairman invited the public to raise any issues and it was asked who owned the layby outside the former mission hall and whether parking is allowed. The consensus of the meeting was that it isn't owned by anyone and it is possible to park as long as it doesn't cause an obstruction.
