## 15/19 CHALE STORES

To receive an update from the working group

The Chairman had asked 6 members drawn from the community with various business expertise to be part of an informal working group and invited a representative from this working group to report back on the first meeting held 3 weeks ago to discuss the shop and how to proceed. An open and honest discussion was had amongst members, and while problems were identified, none were considered insurmountable. It was felt that there are all sorts of opportunities with the existing tenants and to revive the cafe, and that the range of experience within the group could open a number of doors useful to the project moving forward. Backing in principle for the project has been provided by the Leader of the Isle of Wight Council, IW Cllr Dave Stewart and MP Bob Seely. The group will meet again in another couple of weeks.

The Chairman shared the sad news of the death of one of the current co-owners last week and that a celebration of her life is being planned for May 18<sup>th</sup> 2019.

## 16/19 CHALER OF THE YEAR

Possibilities for the award were discussed following the print purchased last year, including the idea of a trophy that could be engraved and passed on each year.

## 17/19 TO RECEIVE REPORTS FROM:

- 1. The Clerk with any correspondence received
  - No more news from Open Reach or IWC re. broadband other than to confirm instead of enabling fibre to the Niton 3 cabinet, a fibre to the premises network is being planned to affected premises in April/May 2020. IW Cllr Stewart is exploring another option in relation to the gaps in the Wight Fibre plan
  - Change of personnel at the National Trust means that a decision isn't anticipated re. the Hoy until at least April.
  - Email received querying one of the payments in the minutes which the Chairman has responded to
  - Winter 2019 District Update received from Island Roads
  - The Draft Island Planning Strategy consultation closes at midday Monday 25 February should Cllrs wish to comment
  - Invitation received to the Isle of Wight Dark Sky Park Campaign event on Friday 22<sup>nd</sup> March in Newchurch
  - New T&PC seminar dates with the IWC received and distributed

## 2. IWC Councillor Dave Stewart

- Met with the Chairman and the owner of Blackgang Chine where the issue of the Old Blackgang Road was raised. There has been a problem with fly tipping and the whole area needs cleaning up. Ideally the owner of Blackgang Chine would like to block the road off and DS has advised him to contact Island Roads who will look into this option for them.
- The caravan at the back of viewpoint carpark is on IWC land and the IWC are investigating legalities to enable removal
- IW Cllr Stewart's report also included parking charges and the budget, future cabinet on the
  road meetings, progress on the combined fire authority, and Brexit meetings with leaders of
  Portsmouth and Southampton to identify sites to relieve pressure on the ports in the event of
  a 'no deal' Brexit
- A special council meeting is being held for the freedom of the Isle of Wight for the founder of the hospice on 13<sup>th</sup> March which will also see a farewell to the current lord lieutenant.

### 3. Parish Councillors

- The Chairman fedback on a public meeting facilitated by IW Cllr Stewart in Niton last weekend where 5 of the 70 members of the public present were from Chale. Areas covered included the White Lion and an application for it to be listed as an asset of community value, overhanging hedges to be cutback by the IWC and landowners to be invoiced, Fishbourne Lane, Children's Services, new 58 million pound Waste and Recycling plant, mainland hospital ferry travel, the Island Plan, street lighting, affordable housing and keyworker scheme, Undercliff Drive, possibilities for a Medina Toll bridge and CARS, who have set up a group to track speed which will include Chale.
- Question was asked about Whale Chine but the Chairman confirmed that although Rights of Way had agreed to relook at the site every 2 months, there are huge cracks and any attempt to create access wouldn't be cost effective or safe.
