## 64/20 VICTORY in JAPAN – 75<sup>th</sup> Anniversary

In view of the Corona Virus the celebrations for VE Day in May had to be cancelled. VJ will be celebrated on Saturday 15 August 2020. As large gatherings are still not allowed, a low-key marking of the event was suggested.

RESOLVED: That a bugler to play the Last Post and the Air Raid Siren will be used at 6pm on Saturday 15 August 2020 to mark the 75<sup>th</sup> Anniversary of the end of the World War in Japan.

### 66/20 TO RECEIVE REPORTS FROM:

- 1 The Clerk provided a short-written report including correspondence received. Both vehicles reported to the Parish Council as abandoned, have been moved since reporting to Island Roads.
- 2 Parish Councillors has nothing to report this month.
- 3 Chairman Councillor Ron Groves advised since CRAB Chale started on 25 March 2020, 193 requests for help have been received, 600 leaflets showing support available have been delivered to residents and 86 food parcels have been delivered. The main requests have been for prescriptions.

He also advised that he understands that someone is interested in taking on the lease for Chale Green Stores.

4 IWC Councillor Dave Stewart - advised that a "Save our Summer" campaign is being used to try and encourage locals to use all the hospitality outlets and tourist activities as numbers of holiday makers on the Island this summer is likely to be greatly reduced. He also said that there has been a Police campaign due to the speeding of motor cycles on the Military Road. Several speeding tickets have been issued. The Diamond Motor Cycle race will now happen in October 2021. Safety of both the participants and spectators will be paramount to the event being staged here.

Following the calls to the IW Council helpline during the Corona Virus pandemic it has been established that there is a lot of food poverty on the Island. Although the numbers of people requesting help has decreased, an average of 39 calls a day in the week and 7 a day at the weekend are still being received. The IW Council have applied to DEFRA for some funding to assist. He praised the work of the local CRAB's and particularly for all Ron's work in Chale.

He is also looking forward to the Chale Show in 2021.

#### 67/20 QUESTIONS FROM MEMBERS OF THE PUBLIC

One member of the public mentioned that he had been involved in a very bad accident on the Appleford Road on 1<sup>st</sup> July. 2 cars had been written off and although there were injuries, no-one was killed. He asked if any warning signs could be installed to try and get drivers too slow down. Councillor Stewart offered to take this problem back to the IW Council who have authority for the highways and request a safety inspection of the road.
