To receive an update and agree on any next steps

The Chairman and Clerk are due to meet the owner of the freehold next Thursday 23rd May and the Chairman will report back to the Board of Trustees after this meeting. The Chairman reported that due to the owner's current personal situation the purchase is unlikely to take place until September. The Chairman reported he has also met with SWAY who are moving quickly to get the café re-opened for the summer as suggested by the owner and very much supported by the current Leaseholders. IW Cllr Stewart keen to write a press release and promote a formal opening in due course.

60/19 FIREWORKS AT BLACKGANG CHINE

To consider a formal objection from the Parish Concil regarding the proposal to increase the number of fireworks to three evenings a week during the summer

Members of the public raised their concerns about Blackgang Chine's proposal to increase the number of fireworks to three evenings a week during the summer at the Annual Parish Meeting held earlier in the evening. Significant concerns were raised about there being no consultation with the community, the huge amount of rubbish left over each night, footpath closures, stress to dogs, horses and livestock, noise pollution, toxic pollution, and damage to wildlife.

IW Cllr Dave Stewart to meet Managing Director, Mr Alec Dabell, on 16th May with the Clerk and Chairman of Niton and Whitwell Parish Council, also affected by this proposal despite their distance from the park, to discuss and request accommodation on the issues raised. IW Cllr Stewart to report back to the Chairman following this meeting.

61/19 HOY MONUMENT

To receive an update and consider asking the National Trust for permission to erect safety warning signs for falling masonry

New General Manager for the Isle of Wight, Mike Greenslade, has agreed to a meeting with the Chairman to understand the PC's proposal more fully. He has explained that one of the main considerations for the Trust is the likely future cost of maintenance and the Investment Board of the Trust would not agree to an acquisition that will be a further draw on resources without an associated source of income.

RESOLVED

To await a meeting with Mr. Mike Greenslade for the Chairman to discuss the proposal more fully including the issue of signage should the Hoy remain under the PC's ownership. It was proposed at this meeting that the historical significance of the monument should be highlighted to the National Trust, not just locally but internationally, and that so much more could be done by the Trust to promote this asset to the Island.
