To engage and consult with employees on day-to-day health and safety Chairman & Staff routinely consulted on health and safety matters as they arise but also formally conditions and provide advice and supervision on occupational health. Clerk to the Council consulted at regular health and safety performance review meetings or sooner if required. To implement emergency procedures - evacuation in case of fire or Escape routes well signed and kept clear at all times.
